- 1. The team recommends to the EOORC Executive to approve a grant of \$538.78 to the Rural United Ministry Cooperative for the purchase of books to support a pastoral charge visioning process.
- 2. The team reaffirms its recommendation of the original grant (previously approved by EOORC Executive) of \$4500. The team recommends Executive approved the additional requested amount of 537.50 to EOORC Music United, creating a total project grant of \$5037.50 to EOORC Music United to fund the travel of musicians to Toronto for the in-person Music United conference in April 2023. Please note: The initial grant was set-aside for the use of Music United, however, due to Covid the project was unable to proceed. As a result of inflation, costs have increased, hence the requirement of the addition 537.50.
- 3. The Team recommends to Executive that a grant of \$5300 be made to Trinity St Andrews United Church, Renfrew to support the initiative of Rainbow Worship Services. The requested a grant of \$5000 will support a series of monthly Sunday evening Rainbow Worship services to welcome the LGBTQ2+ Community and its allies in Renfrew County and communities. Please note: In-kind support to the total project budget of \$9020 will be contributed by the pastoral charge.
- 4. The Team recommends to Executive that a grant of \$8000/year, for a period of three years be made to Emmanuel United Church, Ottawa to support the hiring of a Leader for Children, Youth and Young Adult Ministry. Please Note: Annual progress reports will be required prior to the release of Year 2 and Year 3 funding; and EUC has confirmed that the Pastoral Charge will be absorbing all MERC's related costs and follow all Pastoral Relations requirements where needed.
- 5. The Team recommends to Executive that a grant of 5000/year, for a period of two years be made to Rideau Pastoral Charge, in support of pastoral care ministry through a parish nurse. The objective of this initiative is to formalize and broaden the role, as well as to link it with youth programming, specifically by mentoring young adults interested in pursuing a career in nursing or elsewhere in the health care sector. Please Note: The model of this initiative is to provide an honourarium as

opposed to a formal employment relationship. An annual progress report will be required prior to the release of Year 2 funding.

### <u>Treasurer's Report – Brian Cornelius</u> January 12, 2023

The Finance Committee met on Tuesday, January 10<sup>th</sup> to review the interim financial statement as well as discuss other matters related to the work of the committee

### 2022 Financial Report and Review:

Attached is spreadsheet outlining the interim financial results for 2022. The final results are similar to the projected results with a surplus of over \$100,000 for Governance and a small deficit for Mission and Ministry. The financial outcome still reflects the impact of Covid since the Regional Council has expended less on programming. We can report nothing unusual in our expenditures, other than considerable inflationary impacts related to travel. The costs related to Zion Evangelical United Church are included in congregational reviews. Christine Kilborn and Joe Smarkala from the Finance Committee agreed to sit on the review committee, and we are approaching two other, non-finance committee persons to help with this process, making for a review committee of four.

### 2023 Budget and Preparing for Values Discussion about Budget:

The Finance Committee will be updating the 2023 Budget for final approval at the next Executive meeting. This budget will be based on final outcomes of 2022. This budget needs to be an accurate reflection of costs to provide a solid foundation as the Committee follows through on the motion to guide a values discussion at the May/June annual meeting. The Finance Committee will be having a strategic conversation at its next meeting.

### **Investments with Fiera:**

After many years of exceptional returns, the past year was a year of investment loss, but a loss significantly less than markets given our investment strategy. The numbers have yet to be finalized, but the loss is a little more than 3%. A meeting with our Financial advisors at Fiera occurred on December 1st and access was given to all persons invested in the funds through communities of faith. It was a transparent and informative meeting. Currently, the Finance Committee continues to express confidence in both our investment strategy and Fiera, our investment providers.

### Two Decisions Required of the Executive with Recommendations from the Finance Committee:

There are two actions necessary at this meeting:

- 1. Bequest from Isabel Templeton: Isabel was a member of Maxville United Church which closed last year. Most of the closure money went to Maxville Manor Foundation. In Isabel's will there was money for both that foundation and the United Church of Canada as well as St-Columba House and Montreal City Mission. Outreach was a passion for Isabel, and she was supportive of United Church mission and ministry. The amount of the bequest is \$62,222.00. The Finance Committee recommends that this bequest be invested in the Mission & Ministry Legacy Fund which supports the mission work within the Region, including our Mission Support ministries as well as youth ministry and social justice ventures. This recommendation was moved by Cindy Casey and seconded by Ev Zytveld.
- 2. Kingston Resource Centre: Money was received from the Bay of Quinte Conference from the Kingston Resource Centre to enhance ministry initiatives. We have a request from the Pembroke area churches, the initiative being led by Calvin United Church, for a pilot Parish Nursing project. This has received grant money from the United Church Foundation. We are recommending that the \$13,787.60 in the fund be used for this project, the amounts to be divided evenly between 2023 and 2024, with the second amount

being released on receipt of an update report. This recommendation was moved by James Murray and seconded by Bruce Jackson.

### Outstanding issues:

As mentioned before, we continue to have two outstanding financial matters.

- 1. Since the inception of the Regional Council, monies designated for students have never been granted and that continues. The amount appears on the balance sheet and totals \$9,260.00
- 2. The final closure of Thurso and Campbell's Bay remains incomplete and we hold the proceeds from the sales of buildings. These closures do relate to the cemeteries report for the Western Quebec region.

### Communities of Faith – Restricted Funds:

The Finance Committee has made a commitment to fully review the restricted ministries held by Communities of Faith, and review the present policies and mechanisms for oversight. This review will begin immediately and be an agenda item at a February meeting of the Finance Committee and will provide a framework to offer recommendations and response to the request from Dominion-Chalmers United Church.

### Kindred Works:

In early December, the Finance Committee had an emergency meeting in order to respond to the request of Kindred Works to assist with major repairs at Eglise Unie St. Marc. After reviewing the request as well as discussing the many diverse relationships between Kindred Works and varying churches in the region, the Finance Committee is supportive of a wholistic strategic approach related to EOORC properties and especially in relation to properties in the downtown core of Ottawa (i.e. St. Paul's Eastern, Eglise St. Marc, and Centretown) as well as very important suburban properties such as Aylmer and Hawthorne. We recognize that this relationship does entail financial support and so a framework for tracking these financial relationships has been incorporated into our books and onto our balance sheet.

### Mission Support

The committee agreed to review all our mission support ministries in 2023, and so varying members of the committee "divvied" up the ministries and will take the lead in contacting and getting more information from each ministry in preparation for our recommendations for 2024.

### **Updating Financial Systems:**

The Finance Committee authorized migrating our downloaded QuickBooks program to an on-line QuickBooks program as well as beginning the process of working with the TD bank for increasing our ability to do electronic banking while maintain our "double-authorization" requirements. We are exploring whether we can find a way to help other congregations do a similar migration by purchasing in bulk.



### Comments on Presentations

I really liked the feedback session. So often the feedback goes into a black hole with no feedback. I liked it that we were updated.

Brian gave information prior to the meeting, an outline of his solution and then on Saturday he shared the reasoning. He was clear, succinct and open to questions which none arose.

I believe all the reports were important, so I'm not sure that saying one was more useful to me than another is valuable feedback. I might also know more about certain topics and then say that those topics weren't as 'useful' to me.

Excellent presentations. Missed the table setup - chance to talk to others

Town Halls can be hit and miss but this one was excellent. Good questions and thoughtful responses. Thank you.

The comments that individuals made during the Town Hall were all important, as they contributed to the picture of a whole, so we could see that the presentations we had heard were all connected. Dr Anthony Bailey expressed it best when he said we may be "anti-racist", but we need to start with the concept of what we are for.

If we are for the essential sacredness of every human being, if we see each individual first as a human being, made in the image of God, then we will be less likely to "other" people based on what group(s) they can be sorted into.

The technical aspects during the presentations were incredibly frustrating. Sound levels were inconsistent, and some we couldn't hear at all. It was a beautiful day outside, so I resented the time I spent on presentations I couldn't hear.

The Multifaith Housing Initiative speaker took way more time than was allotted. Next time it needs to be a video presentation or we need to be prepared to cut them off. Sorry, to have to say this.

The MHI report was the highlight of the day for me. Would love to get some electronic materials for that.

January 12, 2023 Zoom and teleconferencing

The Affirming presentation was disappointing. The explanation of pronouns was confusing and seemed to be confusing nonbinary with trans. I am wondering if the Affirming task group has been in contact with any of the Affirming Ministries in the Regional Council.

I found that the majority of the presentations lacked enthusiasm-vigour; they failed to engage us fully. Poor use of the screen: the text was too small and lacked contrast with the background - Sound problems caused by speakers not speaking into the mike properly.

I would have liked to see the new ordinands stand- what a joy for our region. I would also like to have had introductions for the new ministers. Several have "come from away" and we do not know them. We could have been more welcoming. On the whole, the meeting was great!

It may be more beneficial to have some presentations sent out in video / print format prior to the meeting. More time could be spent in conversation and discussion. Having The Feedback Report: Living into the New Structure prior to the meeting would have been helpful. Getting the information at the meeting was interesting, but without time to digest the information and then ask meaningful questions was challenging. The Town Hall format / question could have been sent out prior to the meeting to allow for preparation.

Some of the "announcements" regarding the table displays were helpful as they prompted me to have useful discussions with several display table hosts.

All presentations were well delivered. It is always a time planning consideration on how to divide time between in person reports and printed reports. What information out of a printed report needs special floor attention? What needs court approval? If the region is together what big topics need input or education? What would happen if Region invited Jennifer Henry, GC staff, to a virtual Town Hall meeting, facilitated by Peter Bartlett, to expand on It's all Connected? Region could also offer Pastoral Relations/Whit Strong's presentation on Models of Ministry (that's not the correct title) again.

We hear in the feedback report that communications is a critical issue. The Communications staff person responds by giving a talk on using images. The Personnel minister reports that 1/3 of congregations do not have paid accountable ministry. We hear nothing of how this is stretching the remaining human resources. Office of vocation reports they are trying to catch up on the backlog. No mention that OV has closed the Admissions list because congregations won't hire ministers that are BIPOC. Francophone ministers call out the meeting on its failure to be inclusive antiracists. We hear about the UCC's new strategic plan. Lots of talk about the importance of social justice, but no mention of how to nurture a faith that will produce such fruits of the Spirit.

All of it was informative, important information, well presented, easy to understand

Really, all reports were informative within their bounds. It was more a matter of which subjects interested the listener more. Some were, by the definition of the subject matter more ordinary but that was not a comment on how they were presented - just reality.

Overall the presentations were engaging.

### Comments on Overall Meeting

A very good meeting overall. Nice to be able to gather in person.

BEING IN PERSON!!! Being a community of faith together again with the energy that that always generates A time of remembrance for those \*presbyters "no longer with us.

I brought my own lunch and ate in an out-of-the-way area. Then I went into the lunch area for coffee. As I looked for a place to sit, I was struck by the irony -- we wore masks and sat apart in the sanctuary, silent for the most part. At lunch -- no masks, sitting close together, talking to one another face to face, air from mouths passing back and forth. THEN people put

their masks back on to enter the sanctuary! Duh! Why bother? If there were viruses floating around, they were already well circulated. A bit of a laugh situation eh! So next time if health departments are urging caution? Bring your own lunch and eat away from each other. The host facility hoping to make money won't like it but that's too bad.

I think, we cannot move forward as a regional council unless we make an effort to get to know each other. The executive know the region, but the region does not know each other. We are formed from parts of three other conferences. This cannot be ignored, nor strengthened unless we acknowledge that Covid has delayed this. Nothing can grow until our sense of knowing and belonging with each other is grounded in foundation. As well, I think we are devoting a lot of time to beginning initiatives and not really moving initiatives forward. I sense restlessness in getting on with addressing othering and fostering welcome and inclusion. I also think some of the presentations, while interesting were not addressed to the right audience, such as Anita's presentation on copyright. Where we know that communications are an issue, a presentation on what the challenges are and how we can help with communications would have been more helpful.

When I was talking with an Anglican colleague, she told me that when they met together, that they spent some time talking about self-care as so many clergy are so exhausted due to covid. There were specific instructions about how much to work etc. As I talked with people individually, it was clear to me that many people are tired, some dealing with mental challenges in themselves and/or their loved ones -both clergy and lay people -due to covid. I wonder if it would be useful to address this in a Regional meeting, as it can be so hard to do 'business as usual' when the energy isn't there for some. It can be helpful, I think, even to name this, and to not just talk about exhaustion etc. once, but as often as it's needed. We're not out of covid yet... how do we clergy and lay folk practise self-care, and is there a way to even have peers check up on one another and encourage one another to take the time they are entitled to be away from work so they're not doing crazy hours? I'm just throwing out ideas. There are no doubt many more. When many churches are close to closing, and when many parishioners are having added challenges, the workload can skyrocket for clergy and the few working in the church. This, combined with covid exhaustion can be a recipe for burn out or compassion fatigue or an anxiety disorder etc. Can we as a region provide some sort of help to those on the brink of collapse or decreased health so they can turn around before it becomes worse? Even by providing knowledge about recognizing warning signs? ...or...something else???????

So good to meet in person.

We need to include more French into our proceedings: the "Call to Order", hymns (the closing worship had French), prayers, etc. We all missed this in the planning process. While "Song of Community" as a nice tune, it had too many verses for singing (my opinion). We need to figure out how to make the in-person meetings less lecture-format and more interactive. Maybe it's just me, but I'm not sure what was gained in the "Town Hall" portion of the meeting.

More discussion and decision-making time is required. This is primarily a court of the church, not a vehicle for communication. Far too much is in the hands of staff and executive. We only meet 3x a year and yet there were zero substantive decisions.

Would suggest the groups funded by EOORC be given the opportunity to have a table to showcase their activities and/or allow then a minute to 90 seconds to talk about their work either live or on video.

It was great to see people! - One parliamentary procedure comment - the chair of the meeting is not to move motions according to Bourinot's rules of order. - Disappointed that the celebration of Rosemary was at the end of the meeting when so many had left - so few left to share in the cake!

It was great to get together, but I would have very much appreciated some 'table-time', breakout groups for sharing of thoughts. I also deplore the fact that French language and news from Ministères en français, were totally absent, except for the 2 hymns chosen for Rosemary's celebration - (one had typo)

Thank you for the meeting. Everything was well organized. Speakers were respectful of time allotted. Meeting schedule went well. I went home for lunch as I live nearby and had a couple of things to do. I returned for the afternoon and enjoyed presentations on Communications and Media. I will send this information to our church administrator. Also enjoyed MHI presentation, OSTS, and Town Hall. Thank you for keeping us informed and engaged!

Highlights: \* seeing former Community of Faith members and making new connections with EOORC delegates / attendees.

\* Feedback Report from Living into the New Structure was comprehensive but waited 6 months for publication / presentation. \* the Budget Report provided information about an investment opportunity. \* Camp Awesome Report provided some information which will assist in fulfilling one of our goals. Improvement: \* fewer reports given verbally. Some were quite lengthy while another was simply a reading of already received print material. \* much more time needs to be made to share best practices, strategies for success and celebration of achievements. Comment: As a retired elementary administrator, I have worked though organizational restructuring. When a new governance model is introduced without a strategy or resources for implementation, people revert to a known entity and work in isolation while struggling to make sense of the new one. Without proper guidance, planning, sufficient resources (financial and human), and time (to practise, share best practices and celebrate success), the goals will not be achieved.

I am thankful for the hospitality offered during the day by Bells Corners United Church. It was good to be able to meet people in person whom I hadn't seen for two years and to meet over lunch members of the clergy who are new to EOOR. The meeting was well run and the presentations for the most part were useful. There, was no real opportunity, though, during the day to meet in smaller groups. Most of the presentations was focused on providing information with few opportunities for meaningful feedback.

Promotion was great but the notice that the documents were available was very late. For those of us with poor rural internet it can sometimes take a few days to download material due to internet availability and bandwidth issues. Then we still need time to read and digest. A target of one week in advance would be good. The display tables were very good to have - we need more. But the area in which they were setup was very congested. BCUC is a great venue and there was space to spread out the tables more. I would like to have seen each of the camps have a display. Were they invited?

The highlight was seeing/visiting with people including hospitality of host community of faith with snacks, lunch--generous portions (no one leaves the table hungry), good (for most part) sound, good court discussion on anti-racism. The big oversight was the lack of commitment to bilingualism in Region, both in the report and at the meeting. This is a non-negotiable aspect of the Region, in my opinion. It should be part of the budget and there are people who are more than willing to translate sections of proceedings for a non-bilingual person to read. Would it have been possible for a bilingual person to assist the presider at the table? This has been done. What does Equity Support have to say about this? Is the President-elect bilingual, or willing to take language training? Brian Cornelius and I did language training to develop our comfort levels in presiding. It would be helpful to have a report from GC44 commissioners especially since some approved proposals directly affect Region. It would not be too late to get a virtual meeting to discuss outcomes and to distribute a report. This is a big disconnect from GC to Region. GC44 will meet next year again, so this is an ongoing commitment from commissioners to the region/communities of faith. Past practice in M & O Conference was for commissioners to meet before GC to review proposals, and to meet afterwards, and to report in presbyteries and at conference.

It was great to be together - but a long time to sit in pews. It would have been good to have some time to get up and move and meet with other people in addition to the health breaks and lunch, we have not had the opportunity, due to the pandemic to become a cohesive unit as a Region and still stick with our former Presbytery colleagues. An icebreaker activity or being put into mixed groups to complete a task would have been a good way to get to know each other. We were very thrilled to host the event at BCUC!

I really wish that the "head table" (Whit, Sue, and Joel) would have introduced themselves. They insisted that others do so, but never did themselves.

Eeyore has closed a record number of congregations, with even more hanging on without benefit of paid accountable ministry. Staff and remaining clergy are struggling. A record number of clergy are retiring or are about to. Lay leaders in congregations are exhausted after close to 3 years of pandemic. You've done nothing to address any of these issues.

I think things moved along in a timely matter. The schedule was pretty well held to and didn't vary too much from it. Finishing at 3 was good for those of us with a reasonably long travel. Which is why I didn't stay for the cake.

January 12, 2023 Zoom and teleconferencing

Given that we were meeting in the Sanctuary, I would agree with the presenter that a Town Hall method was the best way to go. It would be best if and when we feel comfortable, if we could go back to a table group setting.

The remarks from the floor by Rev Anthony Bailey were the high light and the most valuable contribution to our increased focus on humanity as a priority within the region and nationally. We need a follow up presentation helping us to move forward with steps on how to achieve the challenge.

Good to meet in person. Thank you to Whit for book tables.

The choice of location was excellent / lots of parking / places in building to be on my own when taking off my mask at coffee break.

Highlights - being together in person Opportunities for improvement - introduce those who are new to EOORC by inviting them forward so we can see them (because of time constraints there is no need for them to speak) - this would facilitate further conversations with new folks during the breaks. Thanks for a great gathering!

The highlight was Dr. Anthony Bailey's remarks on Racism.

Concerning the length of the meeting, some participants felt they had to leave before we marked Rosemary's retirement and many of us did not stay for cake.
