Discussion: Rev. Eric Hebert-Daly provided background for the decision to reconsider the motions and the procedural steps that can be taken. Eric also suggested an intentional thought process to consider the movement of the spirit be devised when helping congregations to discern any reorientation; suggested himself, Rev. Whit Strong and Rev. Dr. Peter Bartlett create the process. Eric will communicate the decision taken and inform them that Trustees will be required to follow the Policy Regarding the Proceeds of the Sale of Property.

3. Finance – Rev. Brian Cornelius, Regional Council Treasurer

The Finance Committee met last week and here is a brief report. There is no financial report on the numbers because we have yet to receive the information from General Council. In January and February, there is minimal activity.

1. Status of Mission Support Reviews: The committee updated one another one their work and one report was received from Christine Kilborn. We made a commitment to complete this work by the end of March.

2. At the last Executive, the Executive asked the Finance Committee for clarification whether the policies impact liquid assets as a separate entity from property (real) assets as a separate entity, or all the assets combined and treated as one asset. This clarification is necessary because it impacts the overall percentages. After a lengthy discussion, the Finance Committee passed a motion moved by James Murray and seconded by Christine Kilburn, that the Finance Committee offer the recommendation that liquid assets and property (real) assets be treated separately and the policy apply to both.

3. Policy on use of Restricted Funds: Presently, the understanding is that liquid assets that are protected and restricted are invested to generate income for a Community of Faith by allowing the community of faith to earn revenue by transferring 4% of the value of the invested funds as of December 31 in the prior year. as revenue. There are changes in CRA guidelines which require a minimum of 3.5% on the first million and 5% on amounts subsequent to that. After discussion, the Committee passed a motion, moved by James Murray and seconded by Joe Smarkala, that the Finance Committee adopt a policy which allows Community of Faith to garner revenue by transferring up to 5% of the total value of the invested funds as of December 31 in the prior year, as long as the original investment remains intact. We recommend that the Executive adopt this as a Regional policy.

4. The committee reviewed the ministry plan from Trinity United in Smith Falls. While appreciative of the plan, specified dollar amounts were not included. The Committee instructed Brian to offer this feedback and communicate to Smith Falls. At this point, they offer no view to the Executive on the adoption of the present ministry plan.

5. The committee received information for the establishment of a Legacy Fund for LLWL to be established from the proceeds from Zion Memorial Apple Hill. There was concurrence with this proposal and the Finance Committee recommends this plan to the Executive with properly established terms of reference.

6. Cindy Casey led a discussion on the forms for bursaries for Candidates for Ministry and RCCO organ lessons. These were adopted and to be forwarded to the Executive for final approval. The Finance Committee will become responsible for reviewing these applications.

### c) Establishing of a Legacy Fund for Licensed Lay Worship Leaders

**2023-03-09\_011 MOTION** (C. Casey/C. Ryan) that the Eastern Ontario Outaouais Regional Council Executive receive the recommendation from the Finance Leadership, as a follow up to the August 15, 2022 communication to Eastern Ontario Outaouais Regional Council, and establish the Zion Memorial Apple Hill Legacy Fund with the following terms of reference:

- 1. An Annual income will be granted from the Legacy Fund of Zion United Church, Apple Hill Pastoral Charge in keeping with the investment policy of Eastern Ontario Outaouais Regional Council, for the purposes of providing a fully paid Gathering Day or perhaps even a weekend retreat or a series of learning event for Licensed Lay Worship Leaders.
- 2. If proceeds from the annual investment exceed the costs of the weekend retreat or learning event, providing funds for other retreats and learning events for ministry personnel or lay leadership in the church is permissible.
- 3. If the ministry of Lay Licensed Worship Leaders ceases to exist, the legacy fund would be used to fund learning events for the successor ministry or for those engaged in church leadership.

Discussion: It was established that the amount is roughly \$200,000 and this would garnish around \$8,000 to be used each year. It was suggested to also include LLWLs when revisiting terms of reference in the future. It was highlighted that this fund may help diversify LLWL operating within the Regional Council.

To Rev Whit Strong EOORC

Re Sale of St Andrews United Church Griffith (Matawatchan) Ontario

Dear Rev. Strong

The sale of the property at 1812 Frontenac Road, Greater Madawaska Township, was completed on October 25,2022 and \$238,056.57, the proceeds net of disbursements, deposited in the account of St. Andrew's United Church. We will send 10% (\$23,806) to the Indigenous Ministries Fund at EOORC shortly.

The Trustees of St. Andrew's United Church and St. Luke's United Church have met to discuss investment of the remainder of the proceeds, \$214,250. We are exploring various investment vehicles, including EOORC's Consolidated Investment Fund with Fiera Capital, The United Church Foundation's partner Canoe Financial, or our current financial institution, the Bank of Montreal. The policy of EOORC is that such an investment would be structured so that only 4% per annum would be available to the new community of faith. This would be an amount of \$8570 per year, subject to fluctuations of earned interest. We would like to submit a proposal that all the \$214,250 be immediately invested, but that \$100,000 of that amount not be subject to the limitation of the 4% withdrawal.

Our charge has been without the leadership of paid, accountable clergy since June 30, 2021. We did not feel it was appropriate to search for new ministry personnel when the viability of one of the communities of faith was in question and the availability of resources uncertain. We are now able to consider the possibility of searching for a new minister. Coincidentally, we learned from yourself that a charge, Emmanuel Land o'Lakes in neighbouring East Central Ontario Region, is considering a collaborative arrangement for two half-time positions and is interested in discussions with us. Rev. Phil Wilson has reached out to Catherine Grant, our charge's representative to EOORC, and proposed an initial meeting for representatives of both communities of faith to learn what is involved in such an arrangement.

Our review of our financial situation leads us to believe that we could support our share of the cost of a half-time ministry personnel, but that there would not be much margin for unforeseen circumstances. We could with more confidence and good faith enter into such an obligation if there was a portion of our funds that was not restricted. In addition to the above, the church building at Denbigh, while suitable to our needs and with excellent acoustics, is over 60 years old and maintenance is inevitable. We would like to recommend to our community of faith that they consider and prioritize projects to improve energy efficiency, accessibility and back-up power generation during times of hydro outages. We understand that partial funding for such capital projects is available in the Region, notably from the Church Extension Committee, but are concerned that we might be short the full 50% of the cost which would be our contribution.

In summary, we are seeking greater flexibility to enable us to make decisions on hiring a minister and for undertaking capital projects. The two congregations have been worshiping together since last November and there is a very positive feeling during our times together. We want to face the future with confidence as well as faith. We propose December 31, 2022 as the formal Amalgamation Date.

Thank you for your consideration of our proposal.

# **EOORC Education Bursary Guidelines**

**Oversight:** A sub-committee (3 members) of the EOORC Finance Team is responsible for the disbursement of funds for the EOORC Educational Bursary. This fund is the result of two significant pieces of work of two of EOORC former presbyteries. The former Four Rivers Presbytery provided an specific amount within their budget to support those seeking organ lessons; and the Education & Students Fund was established by the former Ottawa Presbytery for candidates for ministry in all streams (Ordained, Diaconal, and Designated Lay). Melding these to pieces together, this fund is now open to the entirety of the Eastern Ontario-Outaouais Region.

**Potential Applicants:** The bursaries are available to active members in congregations of the Eastern Ontario-Outaouais Region who are registered as students in universities and other post-secondary institutions in Canada; as well as those furthering their training in Organ performance in keeping with the standards set through the Royal Canadian College of Organists or a RCCO Certified Member.

**Application Review:** Applications will be reviewed within 30 days of the application deadline. Acknowledgement of funding will be made to the applicant will be made with two-weeks of the review and the funds will be dispersed in a timely fashion.

**Application Deadlines:** Applicants will be reviewed twice annually, with the deadline dates of May 15<sup>th</sup>, and November 15<sup>th</sup> of each calendar year.

# Community of Faith (CoF) self-assessments

This is an administrative form for what is expected of congregations. It is not meant to replace pastoral care and oversight visits that reflect the health of the congregation. The governing board of the congregation fills out and submits the form.

It was suggested the background be changed since it is not consistent with what is expected. Without that the form become a compliance rather than a support document.

# Pastoral Care and Oversight Visits

The Executive is still looking at this. It is important but how do we go about it? The Executive reacts to proposals. Peter Bartlett and Whit are working on it.

### **Regional Pastoral Charge Supervisor (PCS)**

A letter was received from Trinity St. Andrew's U.C., Renfrew suggesting the creation of a PCS Regional position might be the solution to the significant numbers of volunteers currently needed in the Region to fulfill this role. The Executive has discussed the suggestion as have numerous other regions. The idea is good – unfortunately, the logistics are not feasible.

Another suggestion is to encourage those in part-time ministry to consider being a PCS as a possible source of extra income.

### Publishing minister's remuneration

Whit provided the motion from the last Executive meeting regarding publishing ministers' remuneration in PRC and/or Executive minutes.

**MOTION 2023-02-09\_012** (T. Demirdjian-Petro/L. Church) "that the Eastern Ontario Outaouais Regional Council Executive no longer publish salary figures and other compensation in the minutes of the Pastoral Relations Commission or the Executive." **CARRIED** 

### Minimum time/length of appointments for candidates for ordination

There is currently no policy regarding this. In the previous Presbytery/Conference system, the requirement was no less than 14 hours and a minimum of one year appointment. Ordination and appointments are now done by the Region so the Region sets the standards.

It was agreed to leave discussion on this item until the March PRC meeting.
