Eric bring a different management style and many experiences and insights that will serve us well. Welcome Eric, it has been a pleasure to start 2023 with you. If you have not met Eric yet, please introduce yourself to him at the AGM. Also, if he taps you on the shoulder to help on a leadership team or a short-term activity, please share your gifts because EOORC can use your skills to "Binging Courageous Community"

The winds of change started showing us the world without the pandemic, how our lives have changed when it comes to meeting and in person gatherings. We are still learning how church and community will be looking in the future. Our November Mid-term General Meeting was called "Re-membering Beloved Community." This gave us a chance to look at our vulnerabilities and brokenness head on, we learned a lot about ourselves and about our need for translation at meeting and to be more Responsive to Equity needs like hearing impaired when we meet. We learned that we miss the activities and social times we had during the old model of Governance, and this has given the Executive and leadership teams lots to think about in order to improve belonging as a region and getting to know each other. As you know when we started as EOORC the Pandemic hit after our first in person AGM so most of us have not gotten to know each other yet.

Rev. Dr. Peter Bartlett, took on a huge job head on, Minister for Visioning with Communities of Faith, Clusters and Social Justice and Outreach Networks. Peter has been working and walking with many Communities of Faith as they meet the new challenges after the pandemic. Our winter event was all about "Building Stronger Communities." This was our Zoom only education event with three Guest speakers. Rev. Regional Handbook with new language, replacing the word "mission", making us ground breakers ahead of General Council who will also be taking on this process over the next few years.

I keep referring to the winds of change but in true fact it is the Holy Spirit blowing through all of us to help us move forward into our New Future as EOORC. Minister for Pastoral Relations' Report

In the Eastern Ontario Outaouais Regional Council, we have 131 active (pre-retirement) Ministry Personnel, 154 retired Ministry Personnel, and 180 individual Communities of Faith. Needless to say, this has been a very busy year as I seek to carry out my work across the Regional Council.

As the Regional Minister for Pastoral Relations, my responsibilities include but not limited to:

- Assisting the Regional Council to live out its oversight of Communities of Faith
- Resource to and support of the Regional Council's Pastoral Relations Commission
- Supporting Communities of Faith discern their options as they live out their ministry
- Supporting Communities of Faith in the search and selection process
- Supporting Communities of Faith who are without called or appointed Ministry Personnel
- Ensuring that Community of Faith support is done in an effective and consistent manner
- Tracking the training and accreditation of Licenced Lay Worship Leaders and Sacraments Elders
- Supporting the work of Church Councils/Boards in all aspects of their life
- Supporting and training Ministry & Personnel Committees
- Assisting Communities of Faith who are in conflictual situations through mediation, dispute resolution and J4 Congregational Reviews
- Fostering collegiality and support for Ministry Personnel
- Liaise with and support the Office of Vocation Minister as needed
- Offer support and resource to the Committees of the Regional Council as requested

Through the magic of Zoom, I host gatherings of:

- Licenced Lay Worship Leaders
- Ministry Personnel
- Congregational Pastoral Care leadership

I continue to have regular meetings with the:

- EOORC Executive & Staff

- EOORC Pastoral Relations Commission

- Congregational Support Ministers nationally
- Vocational Minister

In 2022 – 2023 I led the following online workshops:

The majority of my time is occupied with support of the pastoral relations work of the Regional Council by working closely with the Pastoral Relations Commission, supporting individual Ministry Personnel as they work through personal or professional issues, joining Community of Faith Council meetings as they discuss both daily issues as well as future visions, and working with Ministry & Personnel Committees to resolve issues in the pastoral relationship. I am supported in my work through monthly online gatherings of the Regional Pastoral Relations Ministers from across the United Church of Canada, as well as by the others on staff within our own Regional Council.

Once again, this past year has been a very trying time for Communities of Faith and Ministry Personnel alike. We are all feeling the pressure of changing demographics, and declining finances. We have Communities of Faith who are without regularly appointed or called ministers, often for years, but there is still hope for the church if we discover new ways to bring the ministry of our Communities of Faith to life. As many of us have said, the new "normal" will not look anything like what we have known in the past. Together we can discover ways to remain alive and relevant in our world.

I am always available to work with your Community of Faith as you live out your ministry and as you dream of future successes.

Office of Vocation Report

Office of / Bureau de la Deep Spirituality, Bold Discipleship, Daring Justice VOCATION Greetings from your Vocation Ministers, Rev. Caroline Penhale and

Rev. Lillian Roberts. We are grateful for the invitation to share with Eastern Ontario Outaouais Regional Council an overview of the work of the Office of Vocation since Spring 2022 and a preview of what our work will be in the coming year.

A Year in Review

2022 brought several staff changes to the Office of Vocation. In September, Rev. Caroline Penhale and Rev. Lillian Roberts started serving in a job-sharing model which has Caroline relating to the people and processes connected to Candidacy Pathway and Lillian relating to the people and processes connected to accountability and oversight of ministry personnel. Caroline will assume the full position of Vocation Minister to EOORC, Nakonha:ka RC, and ECORC, effective July 1, 2023.

In the past year, much of the ministry of the serving Vocation Ministers has been supporting the ongoing work of the Quebec and Eastern Ontario Candidacy Board as it accompanies applicants and candidates discerning and preparing for ministry, the administrative support related to ChurchHub for ministry personnel requesting to be available for call or appointment, providing letters of good standing, being available to candidates and ministry personnel who have questions and could use support. The Vocational Ministers network regularly with Regional Council staff, particularly the Pastoral Relations Minister.

The ministry of the Office of Vocation is supported by volunteers who serve on various boards and committees, including the Board of Vocation and the Quebec and Eastern Ontario Candidacy Board. Since September 2022, the Candidacy Board of Quebec and East Ontario has met 5 times. These volunteer board members have worked hard, **interviewing over 2 dozen applicants and candidates** and familiarizing themselves with the processes and policies of the Office of Vocation and specifically, the Candidacy Pathway. We are grateful for all those who give of their time and wisdom to support this area of the Church's ministry!

Looking Ahead

There are some updates coming from the Office of Vocation that are important for ministry personnel to know. The first is an addition to the **Standards of Practice** which now adds a **competency related to the use of technology in congregational life**. During the pandemic we learned the value of ministry leadership being able to utilize technology in order to function well and this addition reflects that learning and expectation. The second is related to standards for Continuing Education which is process at this time. This instruction for priorities articulates the areas of learning that the Church identifies as foundational to the practice of ministry.

If you go to the United Church of Canada website and search for **admissions**, you'll find that the admission process is currently not accepting new applications. This pause does not mean that our work with admission ministers is paused. It is merely allowing us to focus our energy on supporting the 194 ministers who are already at various stages within the admission process.

In 2022, the Admission Board conducted 36 interviews; and another 12 have already been conducted in 2023. Meanwhile, the Matching Commission is piloting a new program that we hope will make it easier

for Admission Ministers to find the appointments they need to complete the admission process; with five ministers looking forward to joining us this year through the pilot program. Having already come through such interviews and appointments, this spring we are collectively celebrating with 11 ministers who have completed the admission process and will be admitted to the Order of Ministry in The United Church of Canada.

The United Church of Canada's strategic plan is encapsulated in the words "Deep Spirituality, Bold Discipleship and Daring Justice", and the Office of Vocation is playing an important role in nurturing faithful and effective leadership with these words in mind. We are striving to create a culture of accountability that is rooted in faith, able to articulate its purpose and willing to risk doing justice.

Deep spirituality informs the work we are doing with applicants and candidates exploring their call to ministry, and with ministry personnel moving through an oversight process. The learning outcomes for candidates for ministry and the standards of practice and ethical standards to which ministry personnel are held accountable, ground the oversight of the Office of Vocation in a deep place of faith, relationship and shared values across the church.

Equipping and supporting "bold discipleship" is part of the discernment conversations that happen between the Candidacy Board and students and is intricately woven into helping shape leaders who are effective and faithful. Bold discipleship understands the importance of faithful boundaries and an awareness of cultural privilege and bias, and the need to hold authority and power with care and awareness.

The Office of Vocation *models "daring justice"* in the way it approaches its work, ensuring there is fair and just process and policies to guide people through candidacy and oversight. We aim to undertake the responsibility we have for oversight with care and diligence. Justice work includes accountability of leadership.

Finance Report

The Finance Committee meets regularly through the year at the call of the Treasurer, Brian Cornelius.

2022 Reviewed Financial Statements:

Attached are the 2022 Reviewed Financial statements for the Regional Council, and full review took place in April of 2023. These financial statements will be included with the CRA 3010 filing that is submitted prior to June 30th, 2023.

The Regional Council ended up with a surplus for the year of \$99,921 (a surplus of 101,817 for governance and a deficit of \$1,897 for Mission and Ministry). This surplus is because of limited Regional Council activities given the Covid-19 pandemic.

In 2022, the Regional Council created the "Mission and Ministry Legacy Fund" as part of the adoption of an updated policy for the disbursements of funds at the time a Community of Faith disbands. This fund enables the Regional Council to maintain ministries within the Region by offsetting the reduction in

Mission and Service grants. Ultimately this may help us maintain our level of mission support to our outreach ministries. The Executive reallocated \$120,000 from the surplus from unrestricted governance Funds and \$30,000 from unrestricted Mission and Ministry funds to establish this fund.

The three-year pilot project for a Camp Awesome Director was also implemented in 2022 through the reallocation of unrestricted funds.

All the details of expenditures are included in the 2022 Financial Statement and we welcome any questions about the details.

Motion Required:

That the 2022 Financial Statement for Eastern Ontario Outaouais Regional Council be formally received and accepted.

Motion Required:

That the Executive of the Eastern Ontario Outaouais Regional Council appoint an Internal Independent Review Committee to review and produce the 2023 Financial Statements.

2023 Financial Report and 2023 Budget

We have circulated a report for the first third of 2022, April 30th. The report includes the budgeted amounts that were adopted last November and we note that the Regional Council did authorize a deficit. We anticipate, now that Covid-19 restrictions no longer exist, that we will incur a deficit in 2023. As explained in November, we look to the strategic planning process to guide decision making processes so that the Regional Council operates with a balanced budget in 2024 and onwards.

Investment Funds

The Finance Committee continues to be satisfied with our investment arrangement with Fiera Capital Investments, which is the same investment company used by the United Church of Canada and the United Church Foundation. The Finance Committee met with our investment representatives to review our investment strategy. We made no changes to the balanced approach adopted previously. We have a pooled fund to maximize investment returns and reduce investment costs.

The policy of the Finance Committee is to transfer 4% of the value of the funds on December 31st to support the budget of the subsequent year. The amounts are included in the 202e budget. The amount being transferred was reviewed by the Finance Committee and we have now adopted a policy that allows for a transfer up to 5%.

2022 was a negative year for investments, the first in several years.

- 2023 4.7% (until April 30th)
- 2022(4.0%)202116.8%20209.3%

Communities of Faith Investing Through the Regional Council

Beginning in January of 2022, on recommendation from the Finance Committee, the Executive approved a vehicle for the Regional Council to "hold-in-trust" investments for Communities of Faith through the pooled investment Fund with Fiera Capital.

There are nine (9) Communities of Faith who have invested through EOORC with investments valued at more that 1.5 million. This investment vehicle is primarily available to smaller communities of faith to provide a means to secure a higher return for investments through access to investment opportunities available to the Regional Council through its pooled funds. The Finance Committee welcomes inquiries from communities of faith seeking and information about this investment opportunity is included on the EOORC website.

Mission Support

The Finance Committee oversees Mission Support and makes recommendations for Mission Support grants. The Committee received all requested documentation from Mission Support grant recipients and the Committee carefully reviewed this material. The Mission Support grant recommendations for 2023 were included in the budget. Given the surpluses of previous years, and a time of uncertainty in pandemic, we are maintaining the levels of funding for Mission Support despite the reduction of Mission & Service Fund grant forwarded to Regional Councils.

We recognize that we may not be able to maintain the same level of funding into the future and in 2023, we are undertaking a conscientious review process.

Restricted Ministry Accounts

The Finance Committee administers restricted ministry accounts which provide support to particular ministries. Many of these are short term projects and often receive funding from General Council grants. The purpose of each fund is outlined in the Financial Statements

Restricted Funds held by Community of Faith

The Finance Committee also identified restricted funds within Communities of Faith and has established a process for the annual review of these restricted amounts.

Conclusion

The Finance Committee welcome any questions and suggestion that you have for the effective use of the resources available to the Regional Council. We also, a times, provide support to congregations who are reviewing their financial processes within their own community of faith so that all of us are faithful stewards of the resources we are gifted with.

The members of the Committee are Cindy Casey, Brian Cornelius (Treasurer), Eric Hebert-Daly, Bruce Jackson, Christine Kilburn, James Murray, Joe Smarkala, and Ev Zytveld. The members provide both knowledgeable and faithful guidance to this work.

The Pastoral Relations Commission meets monthly via ZOOM. The Commission membership is Wayne Harris (Chair), Ina Bromley, Charlotte Hoy, Sharon MacDonald, Erin McIntyre, Linda Suddaby, and Jim Allen. We are supported by our Scribe, Karen McLean and Resource person, Rev. Whit Strong.

The Commission thanks Karen McLean for producing the minutes that are on the Region's website and distributing minutes to the members of the commission, the Executive Minister, Program Assistant, Communications and Administration Assistant, and the General Council office.

Through the Liaisons that the Commission has appointed we are supporting the Communities of Faith through their time of transition while preparing their profiles for the ChurchHub and then their search for new ministry personnel.

If you would like to assist Pastoral Charges at this important time in their life story please contact Rev. Whit Strong about the Liaison training. It would be good to spread the workload to involve more people.

The Pastoral Charge Supervisors the Commission appoints are a support and resource to the Community of Faith's governing bodies. Pastoral Charge Supervisors must be members of the Regional Council.

Please contact Rev. Whit Strong if you are able and willing to assist in this important work.

Since the last annual meeting, the Commission has initiated 2 policies for the Region to consider and acknowledged/approved 6 sabbaticals, 4 requests for change in pastoral relations, 4 call, 28 (re-)appointments, 5 Community of Faith profiles, 4 liaisons, 17 pastoral charge supervisors, 4 Sacraments Elders, 3 Mentors for Sacraments Elders and many one of a kind topics on behalf of the Eastern Ontario Outaouais Regional Council.

Nominations

The Nominations Team meets as-needed basis with the bulk of its work being done prior to the three meetings of the Eastern Ontario Outaouais Regional Council (EOORC).

The Region is gradually opening up to live meetings with our meeting in November being held in-person at Bells Corners U.C., but the team continues to meet via Zoom. The challenge of restricting our membership to those with access to internet access has been offset by enabling team members to attend from anywhere in the Region without spending 2-3 hours travelling one-way.

The Executive and Leadership teams also continue to meet regularly – most still via Zoom - to do their part to oversee the "business" of the Region and to also provide support for our member congregations. There is much to be done to enable the Region to operate smoothly as an integral part of the wider United Church of Canada.

There is a team of 9 Staff members but they are there to provide support and oversight to the various leadership teams - we are ultimately responsible for doing the work and determining the direction of our Region. Many have stepped forward to offer their various skills and talents as members of our 17 Leadership teams but there is always room for more.

The mandate of the Nominations Team is *assist* various teams and clusters to seek out and find members as well as to encourage people to serve as General Council commissioners. Thanks to one and all who currently participate in any way in the work of our Region. Your help is so very much appreciated.

If you have volunteered in the past and are taking a break – thank you so much for your gift of time and talent. If you are a new rep from your Community of Faith or just haven't got around to figuring out how you might serve yet, please call or email any of us on the team for help to discern this. Every new pair of hands lightens the load for everyone else.

Licensed lay Worship Leaders Committee

The Licenced Lay Worship Leader Committee has responsibility for the care and oversight of EOOR's 40+ LLWLs and prospective LLWLs who are still in the midst of completing their training program. As it has been over the past few years, due to COVID-19 our LLWLs have not been as busy as in years past, although a number of them have been kept busy with online worship and the occasional in-person worship leadership as restrictions permitted. More Communities of Faith are having in-person worship and our LLWLs are responding as they are able.

Over the past year several of our LLWLs have decided that, after many years of lay worship leadership, that they are "retiring". We thank them for their faithful leadership over these many years. At the same time, we have welcomed several more onboard as new LLWLs.

In the fall of each year, the LLWL Committee is in contact with each LLWL to ensure that all the documentation has been provided to confirm their readiness to be relicensed for continued service. We are pleased to say that the LLWLs have been very prompt in getting all the required paperwork in quickly. In May 2023, the LLWL Committee sponsored an educational workshop: "A Discussion of Inclusivity" which was very well attended. Many thanks to Rev. Jenni Leslie for her leadership in this area.

The LLWL Committee is in contact with our LLWLs as the need arises, and with our prospective LLWLs as they move closer to recognition.

We strongly encourage our Communities of Faith to reach out to our trained LLWLs when pulpit supply is needed.

Church Extension Committee

Report May 2022 to May 2023

Communities of Faith undertaking projects involving their buildings and facilities may apply to the Church Extension Committee for financial assistance on a shared funding basis. Since becoming part of the Eastern Ontario Outaouais Region in January 2019, 43 projects by Communities of Faith have been supported with a total of \$461,623. in funding.

<u>Mandate</u>

The Church Extension Committee manages investments of currently approximately \$4 million and holds a piece of property valued at approximately \$4 million. This enables us to assist Communities of Faith as follows:

- new buildings, land, and facilities for the purpose of establishing new congregations;
- renovations and upgrades to buildings, equipment, facilities and audio-visual technology projects and for disposal and demolition of buildings and facilities;
- providing suggestions and advice regarding ways to approach and finance their projects;
- providing financial guidance and support through grants, loans or mortgages to cover a portion of the costs; and,
- managing the financial assets and the land holding entrusted to the corporation.

Vision Statement

Our Vision: Striving to support the health and continuance of Communities of Faith throughout the Eastern Ontario Outaouais Region with excellent advice and shared financial support for their projects to repair and renew their physical assets.

Assistance Available

Two types of financial assistance are available to Communities of Faith; a non-repayable grant and a repayable loan or mortgage.

The Church Extension Committee will consider grant applications for qualifying projects up to a maximum project cost of \$50,000. In principle, grants are provided on a matching basis; that is, for each dollar contributed by the Community of Faith, Church Extension will provide a matching dollar, up to a maximum grant of \$25,000. Absent truly exceptional circumstances, this maximum of \$25,000 will be in effect for a particular Community of Faith for a three (3) year period. This cap is regardless of the number of grants made during that period, so for example, there may 10 grants of \$2500, 5 grants of \$5000 or 1 grant of \$25,000 during any three (3) year period.

The Committee also considers requests for financial assistance in the form of a loan or a mortgage for projects that fall outside of the guidelines for a grant. The Committee requests information about the Community of Faith's overall financial situation, typically as provided in their latest Annual Report, sources of funding for the project, and the Community of Faith's proposal for repayment of the loan or mortgage. For loans and mortgages, the Community of Faith and the Committee work out repayment terms which take account of the financial capacity of the Community of Faith.

Grants Made by Church Extension – June 2022 to May 2023

The Church Extension Committee is pleased to have provided financial assistance to 10 Communities of Faith since May 2022. Their projects cover a wide range, including repairs to physical infrastructure, an organ, accessibility ramp, parking lot, heating and electrical systems and assistance with an energy efficiency project. Total financial assistance of \$113,508. was provided in the form of non-repayable grants.

Networks and Ministries

Righting Relations Network

The Righting Relations Network is comprised of individuals from nine United Churches, and welcomes more members! The Righting Relations Network formed following some study and discussions on the Truth and Reconciliation Commissions' Calls to Action, the subsequent "Calls to the Church" prepared by Indigenous members of the United Church, and an interest in how to deliver land acknowledgments. Jane Dawson, formerly Minister Supporting Communities of Faith, Clusters and Networks with EOORC, invited some interested United Church members to brainstorm on how we could support each other and pursue right relations within our region. Lori Ransom, United Church Animator for Reconciliation, met with the network to talk about how the United Church is organized to address right relations, some current emphases and directions within our church, and recommendations and practices for land acknowledgments.

During 2021-2022, the Righting Relations Network began some informal and more structured visioning to discern its role. The Rev. Dr. Peter Bartlett, Minister for Visioning with Communities of Faith, Clusters and Social Justice and Outreach Networks within EOORC, guided us through some exercises to help decide our priorities when choosing how or what to tackle in righting relations with Indigenous people. The outcome can be summarized as follows:

- Our Call is to seek justice alongside Indigenous peoples, as together we are moved by the Spirit in all of its diversity and wonderment.
- Our Vision is to be a consultative, collaborating network, responsive to the calls of reconciliation, through building respectful relationships.
- Our Goal is to embody the practices of Spirituality, Learning, Advocacy, Testimony, Healing, and Radical Hospitality.
- We will work toward our Goal through active Listening, effective Communication, meaningful Engagement, loving Accompaniment, and nurturing Self-Support.

The Righting Relations Network holds monthly meetings. We rotate leadership roles so we all contribute to facilitating, taking notes, doing land acknowledgments and offering prayers. Meetings may be focused on a specific subject or speaker, or loosely structured to provide time for networking amongst ourselves, providing updates on recent and future reconciliation events, and identifying themes for future meetings. So far, our meetings have largely focused on discussing some of the Truth and Reconciliation Commission's Calls to Action for churches, local activities that promote reconciliation, and specific initiatives affecting United Churches in our region.

In January 2023, the Righting Relations Network launched its webpage on the EOORC website. We continue to review ideas for what we could post, and who will be responsible for updating the webpage.

Many United Church members were interested in learning about the Rev. Dr. Teresa Burnett-Cole's research on her Th.D. thesis. Teresa presented some highlights on "Indigenous Gifts to Settler Churches", through a webinar arranged by the Righting Relations Network and EOORC personnel, on January 26, 2023. She discussed her research on three types of Indigenous churches (Christian traditionalists, Ceremonial and Expansive/Intercultural) and shared a list of best practices for welcoming, language, music and worship, congregational relationships and avoidance of cultural appropriation.

At the request of EOORC's Affirm Leadership Team, we held a meeting about being an affirming network within EOORC on March 8, 2003. Affirm Leadership Team members Roxanne Akhtar and Bronwen Harman discussed what it means for the region as a whole to become affirming, and how the process of working on righting relations involves being welcoming of people of all gender identities and sexual orientations, and encourages inclusivity with respect to all marginalized people. Since the Righting Relations Network is focused on Indigenous issues, this network could encourage a broader understanding of two-spirited people and their particular gifts from Creator. We may consider hosting a workshop with a speaker interested in sharing about being two-spirited.

We have taken an active interest in the remit process for establishing an autonomous National Indigenous Organization within the United Church of Canada. Between March 15, 2023 and March 31, 2024, every regional council and pastoral charge will be asked to approve an amendment to the Basis of Union to establish an autonomous Indigenous Church structure. The Righting Relations Network is interested in facilitating a positive outcome for this remit process. The network invited Rev. Dr. Teresa Burnett-Cole to speak about the remit on April 26, and members discussed how we might be able to contact all the pastoral charges in EOORC to provide information on the voting process, and ensure educational materials have been received. We look forward to discussing our network's role on this important matter, with EOORC.

UCW

Last September, Vice President, Charlotte Hoy and Past President, Linda Stronski attended the National UCW AGM. At this meeting, Barbara Davison was elected President Elect and the Healing Fund was selected as the fundraising project for the next five years.

During the past year, Area UCW groups met either in person or on Zoom for Fellowship and Leadership Days and some groups in these areas were able to start holding some fundraisers. In April, all four Areas held their yearly AGM's, Seaway Valley in Cardinal, Four Rivers in Brockville, Upper Valley in Renfrew and Ottawa on Zoom.

This year Ottawa is hosting the EOOR UCW AGM at Bells Corners United Church on Tuesday, May 9. The speakers for that day will be Ellie and Clarke Topp, who will speak on the topic of a Guaranteed Livable Income.

Spiritual Care Hospital Ministry (SCHM)

Spiritual Care Hospital Ministry has continued to be largely inactive for the past year due to Pandemic restrictions. Our three ministry teams that normally provide visits and Spiritual Care to United Church patients, have been prevented access to our hospitals for most of the year. The TOH however, began to allow their Spiritual Care visitors to return in November 2022. Clergy were allowed to visit on the request of a patient. The TOH and the QCH hospitals have held virtual Spiritual Care Advisory Committee meetings which our Coordinators attended on behalf of the United Church.

Spiritual Care Hospital Ministry has continued to recruit, and we are pleased to announce that Richard Johnston has joined the General Hospital Spiritual Care team, and Jeremy Geelen has begun work on a survey of hospital Spiritual Care practices in rural areas of our region. Unfortunatly two members of our QCH visiting team have now retired.

We enjoyed our first in person meeting of our Spiritual Care teams in the fall of 2022.

Our visiting teams have continued to participate in on line education seminars with the Ottawa Pastoral Care Training Program, and in on-line hospital visitor certification training.

The Social Justice Network of the Ontario Regional Councils (SJNOR).

SJNOR is the continuation of the former Social Justice Network of the Ontario Conferences (SJNOC) formed many years ago to coordinate the dialogue between the United Church and Queen's Park on social justice issues. As the process has evolved, the network became a useful forum for the exchange of information on social justice ministries across the province, while continuing its traditional role as a vehicle for coordinating policy-dialogue with the provincial government. The network also serves as the channel for United Church annual support to the Interfaith Social Assistance Reform Coalition (ISARC), an Ontario multi- faith advocacy.

Prior to the change in church governance at the beginning of 2019, the seven former conferences in the province of Ontario agreed unanimously to continue to support the work of the network. Like its predecessor SJNOR is governed through a covenant established among the sponsoring Regional Councils. Each Regional Council nominates two members to SJNOR, of which one is typically a volunteer and the other a member of staff. Charles Barrett and Peter Bartlett currently represent EOORC. Charles is also acting as the current Chair of the province-wide network. The covenant specifies that the Chair may serve for a maximum of two two-year terms.

The SJNOR Covenant specifies that the network will meet at a minimum of twice annually. In addition to the Regional Council representatives, meetings are also regularly attended by General Council Office staff in the Division of Church in Mission, by staff from KAIROS, and by the United Church representative to the Interfaith Social Assistance Reform Council (ISARC). The membership benefits from regular briefings on program activities within these organizations.

Meeting may take place either in person or electronically. The past practice had been to gather at Church House in Toronto. Because of the impact of COVID-19 we continued to meet virtually using Zoom throughout 2022. Our spring meeting took the form of a special social justice workshop open to United Church members from across the province. This event took place on Zoom on May 1, 2022, with more than 100 in attendance, and a very positive reception. Our Fall meeting took place on November 24, following our past practice, and was time to coordinate with the ISARC Religious Leaders' Forum.

Reports on past SJNOR meetings, which provide details of the substantive discussions, are available on the EOORC website or from the undersigned. I am grateful to Dr. Ernie Epp, representative from the Canadian Shield Regional Council, our recording secretary, for producing timely and comprehensive records of our discussions.

EOORC – Housing Matters Network



My people will live in peaceful dwelling places, in secure homes, in undisturbed places of rest." (Isaiah 32:18)

The United Church of Canada believes every person living in Canada deserves a safe and affordable place to live that meets their needs. Such housing is a fundamental human right. As people of faith, we are called to act justly and advocate for those who face the many challenges that inadequate housing represents.

In our fourth year, we continue to look to our mission: to be a forum for the exchange of information about (in)affordable housing issues around the region—spanning the inner city to rural locations – and sharing ideas and resources about how we as church can be responsive to these issues.

Our working group is made up of Cathy Ashby (House of Lazarus), Dianne Cardin, Christine Froats, David Sherwin and Sue Smarkala, working to identify topics and speakers of interest to the Housing Matters network. Peter Bartlett continues to provide much appreciated input.

This past year we offered three conversations:

May 18, 2022 – 'Housing Crisis in Rural Eastern Ontario', Cathy Ashby, Executive Director of Lazarus House presenting. Cathy spoke about the desperate need for affordable housing she sees everyday in her work at Lazarus House.

October 4, 2022 – 'A Place to Go", Rev. Dr. Peter Bartlett, Minister for Visioning with Communities of Faith, Clusters and Social Justice and Outreach Networks, EOORC.

Peter spoke about the support he can provide to churches wanting to consider/review their call and their place in the community. Several attendees reached out to continue discussions with Peter.

November 15, 2022 – 'In Conversation with Miriam Bowlby, Kindred Works'. Miriam spoke about the ways that her organization can work with congregations to leverage their property for new and different uses. Many congregations have approached Kindred Works.

Moving into the coming year, we will look for ways to bring good ideas to a broader awareness. For instance, the House of Lazarus has recently opened the new <u>South Dundas Community Hub and Warming</u> <u>Centre</u> in Morrisburg, thanks to the efforts of The House of Lazarus and its community partners, especially the Anglican Parish of South Dundas. These partners have implemented an interesting way to support folks without adequate housing. This community space provides emergency housing, kitchen facilities, social service support, quiet space, computers and laundry facilities. We plan to have Cathy Ashby come and share ideas and successes regards this centre in the near future.

Our website is still rudimentary – an area of activity for the coming year. We continue to move slowly to be sure that we can maintain our plans as volunteers.

We welcome all suggestions of interesting ideas and topical speakers – and new members for our working group.

Every year, MHI hosts Tulipathon, a walkathon fundraiser at Dow's Lake. MHI's 70+ faith group members are invited to walk among the tulips and raise money for the tenants who live at MHI. As always, 100% of net proceeds go to the MHI subsidies program. MHI provides more than \$400, 000 in subsidies to our tenants every year. Please consider joining for the Walk (tomorrow- May 28) or make a donation before the end of June. For information check out <u>www.multifaithhousing.ca</u> or call 613-686-1825.

In recent years, EOORC has supported Veterans' House- The Andy Carswell Building with donations, quilts and shawls. This has been greatly appreciated! The Community Kitchen contains a lovely plaque recognizing the significant financial support from EOORC. The Remembrance Day service there on November 11 is very special, as they all are! As of 2023, Veterans' House-ACB is managed by Veterans' House Canada. Four more Veteran's Homes will be built across the country. All Veterans' Houses will be managed by the brand-new charitable organization – Veterans' House Canada.

Multifaith Housing Initiative was proud and delighted when, on January 20, 2022, the National Capital Commissioned announced Dream LeBreton as the successful proponent to develop the "Library Parcel" of LeBreton Flats. This project will build 601 new residential rental units -- 247 of them affordable. MHI

will own and operate 130 of the affordable units, ranging from 1-3 bedrooms. These affordable units will serve the priority populations identified in Canada's National Housing Strategy: Algonquin and other Indigenous peoples, veterans, recent immigrants, women and children, and adults with cognitive disabilities. The two buildings, which will be 30 and 35 storeys, will include a mix of affordable and market units and will have a gathering circle located prominently between them. It is our hope that EOORC will fundraise for 31 units that will be designated for Indigenous individuals or families. More information will be forthcoming in the fall, including a worship service planned in conjunction with Rev. Dr. Teresa Burnett-Cole. It will be similar to the *United We Stand* service prepared in support of Veterans' House – available for all to use.

Annual Report to Ucc Regional Councils April 2023



Greetings and grace to you as you convene for your Regional Council meeting. May that time nourish and sustain you, as you build up the church and enjoy the goodness of *being* the church.

I am pleased to report that AST has experienced several interesting events and changes in the last year. Here are a few of them.

In the summer of 2022, and for the first time since 2019, we were able to have our summer MDiv students take their courses in person and occupy rooms at the campus residence. I had several opportunities to meet with students both as a group and individually. They were pleased to meet faculty and fellow students in person and to share worship, meals, and recreation with their colleagues.

As the Fall 2022 term began, our courses were offered remotely or in hybrid (both virtually and in-person) form. As none of our own students applied for residence, all our rooms were rented to international students from other institutions in the Halifax area. However, we maintain a policy of preferential availability for AST students. In the meantime, we are remaining true to the fundamental values and mission of AST by reaching out to those who would have to pay much more for accommodations or would be unable to study in Halifax because of a lack of rental spaces.

In other good news, the Province of Nova Scotia has provided AST with a grant of \$3M to renovate and upgrade our residence facilities, work that is long overdue. The funds will allow us to repair brickwork, install new plumbing, make wi-fi system updates, and upgrade shared kitchen and bathroom facilities.

At the May 2023 Convocation, the first cohort of students in the Diploma in Missional Leadership (DML), all of whom are affiliated with the United Church, will graduate from this new program. The next cohort of the DML will begin in early 2024. This learning opportunity will be available to persons from all

denominational backgrounds as we build a new complement of ecumenical partners in mission. AST is currently in the last stages of the formal application processes to launch a Bachelor of Theology degree program. The key purpose of the Bachelor of Theology degree is to increase accessibility to higher education in theological subjects. Those who desire postsecondary education specifically in the theological disciplines but lack an undergraduate degree will benefit from this new degree. A direct-entry undergraduate degree option will assist them in their vocational and educational goals.

A key element of the Strategic Plan adopted by the AST Board in February 2022 is collaboration with Saint Mary's University (Halifax) as part of the now twenty-year old Memorandum of Understanding between our two independent institutions. In the past year, we have integrated our student information infrastructure into the Banner system at SMU. That project, funded by the Nova Scotia government through the NS Council of University Presidents, is almost complete. The initiative has provided significant benefits to our students, faculty, and staff. It has allowed AST to move from paper-based to IT-based processes for handling many things, from course registration to student records and course changes.

We will see some significant leadership changes at AST over the next several months. The Presidential Search Committee (even as this is being written) is nearing the end of its work to find a candidate to propose to the Board as AST's new President. As well, a second search committee is in the process of seeking a new Academic Dean to succeed Rev. Dr. Rob Fennell who has served in that role since 2017. His outstanding contributions to the university have earned him a well-deserved sabbatical which will begin this summer. Finally, Rev. Dr. Linda Yates succeeds Dr. Peter Secord as Chair of AST's Board of Governors.

We would like to express deep gratitude to our partners in The United Church of Canada—the General Council, the Regional Councils, the Board of Governors of Pine Hill Divinity Hall, and the local churches, leaders, and ministers—who support AST's work in a variety of ways. Financial support from the General Council and Pine Hill Divinity Hall are critical to our capacity to function as a university focused on theological education for ordered ministry candidates and lay leaders. The local churches support AST through discernment processes for potential ministry candidates, by encouraging lay people to continue their lifelong faith learning, by calling and supervising our graduates who serve your congregations, and by your vital and deeply valued financial support. If your Community of Faith has not yet made a gift to AST this year, I ask you to consider doing so in the next month or two.

AST continues to seek to be responsive to the emerging needs of the church and society as we serve together in God's world. In this, we are grateful to be your partners.

Centre for Christian Studies – 2022

A Year of Anticipation and Adjustment

2022 for The Centre for Christian Studies was a year full of preparation, anticipation, and adjustment. It began with the departure of David Lappano (former program staff) and Michelle Owens (former principal). It set the stage for two search teams to look for new staff. Meanwhile, Ken Delisle served as the interim principal for most of the year until the arrival of the new principal. Through several months of internal

preparation, discussion, and searching, CCS now has new Program Staff Alcris Limongi and Alan Lai; the new principal. They both started in the month of October.

Alcris Limongi came to CCS from Parkdale United Church in Ottawa, where she served as the Minister of Pastoral Care. Alan came from Vancouver, where he was the minister serving South Arm United Church in Richmond. Alcris originally came from Venezuela, and Alan, Hong Kong. Together, they bring intercultural perspectives and years of leading anti-racism and intercultural learning to the CCS community. Covenanting service for Alcris and Alan were conducted on November 23rd, at Westworth United Church in Winnipeg.

With the assemble of the new team complete, the staff spent the last few months of the year building new relationships and sharing ideas and practices. The spirit of exploration and relationship building was high. With Alan's photographic and video production skills, CCS has begun to post more updates and videos on the school's Facebook page and YouTube channel.

While the searches were going on most of the year, CCS's programs and operation continued smoothly with dedicated staff and volunteers. CCS continues to offer courses online and in-person, which included: Power and Privilege, Ages and Stages, Ministry as Community-building, Health, Pain, & Trauma. CCS Fridays is a series of free, one-hour online workshops and discussions offered mostly once a month to connect friends and the wider community. On April 3rd, during the Annual Service of Celebration, Aileen Urquhart was awarded the Companion of the Centre Award.

Financially, CCS continues to rely on the commitment of the denomination and generous donors who believe in the mission of the school. Lori Stewart, our Development Coordinator, has done a fantastic job connecting with donors and applying for grants and funding. While denomination funding is decreasing, and Endowment portfolio is not as promising as before, we are committed to working towards financial sustainability. We are thankful that many of our donors remain committed to diaconal education and bless us with extraordinary generosity in 2022. CCS is anticipating major Endowment fundraising campaign in the coming years.

There is no doubt the pandemic has challenged the school on many fronts, including programming, student enrolment, marketing, and so on. It disrupted more than just in-person gathering, but also concepts of theological education, teaching, learning, and service in the world. However, the process of rebuilding has begun.

The United Church Studies Program at Montreal Diocesan Theological College Report to the East Central Ontario Regional Council February 2023



Forming a new ecumenical college

The amalgamation of The United Theological College (UTC) and Montreal Diocesan Theological College (Dio) in 2022 is the culmination of five years of planning and collaboration. The process has called for courage and risk, letting go of the past, vision, prayer

and discernment, and a deep commitment to ecumenical collaboration.

In September 2022, Montreal Dio amended its constitution to provide for United Church participation in its governance and agreed to ensure the continuity of United Church theological education in Montreal, under the working name of **United Church Studies at Dio**. It is now required that one-third of the Dio Board be members of the United Church of Canada. The position of Director of United Church Studies was created to support ministry formation in a United Church tradition and ensures that United Church-affiliated students meet requirements for United Church Testamur. Montreal Dio is now an *ecumenical* institution forming students for ministry in the Anglican, United Church, and other traditions, in partnership with the Montreal School of Theology and McGill University.

We are encouraged by the continued growth and increasing diversity of our student body. Over half the United Church-affiliated students are francophone or fluently bilingual, most were born outside North America, and over 85% of them are newcomers to the United Church and to Canada. Outside of our regular degree programs we offer courses for Admission Minsters and a week-long residential orientation program for leaders new to the United Church. These programs are intercultural in nature, opening us up to conversations and relationships that nurture our growth as an institution with regards to justice and spirituality. This rich diversity of language, culture, and tradition is changing us and the church – informing how we teach and learn, how we converse across differences, including theologically, and how we experience God's spirit in our midst.

Courses and Events for Lifelong Learning and Ministry

The amalgamation of UTC and Dio has enabled us to expand our offerings and extend the reach of our programs for lay people and ministry personnel. We are focusing on programs that support a renewed and vibrant church and that help people grow in faith and in leadership.

Open Enrolment Courses Winter 2022 to Spring 2023

These online courses are offered for four to six weeks. Often, groups from congregations take the course together. We offered 9 courses this year on various topics related to the Bible, spiritual formation, and Christian leadership and attracted over 120 participants from across the country.

What Next for the Church: Congregational Ministry in a Pandemic Shaped World

Conflict Resolution Jesus Style

February 9, 2023. Day-long in-person event with The Rev. Susan Brasier, J.D., and The Rev. Dr. Karen Petersen Finch.

Formation for French and Bilingual Ministry

One of our key areas of focus this year has been equipping the church to minister in the unique context of Quebec and strengthening French ministries across the United Church. This includes a partnership agreement with *La Table des ministères en français* of the United Church which helps us to support ministry formation for francophones. We have also expanded our program for bilingual ministry by hiring a dedicated program director to oversee French formation for students and implement the revised *Certificate in Bilingual Ministry* program. In May of 2023, we will be offering a week-long *French for Ministry* intensive course designed to strengthen the linguistic competence and cultural know-how of those working in French or bilingual ministry and pastoral contexts.

Montreal Mission Internship

In summer 2022, Dio launched the Montreal Mission Internship, a 9-week program for 18- to 25-year-olds that combines social service work with theological reflection and intentional community. Last summer, thirteen young adults from across the country came to Dio to put their faith into action and explore a call to Christian ministry beyond the walls of the church. Applications are now open for the 2023 program, which has been expanded to host 18 participants.

United Church Orientation Learning Circle May 2022 and May 2023

A week-long residential event was held in Montreal from May 30 to June 3, 2022 for United Church Admission Ministers to learn the historical and theological context of the United Church, the core values,

structures, policies, and vision; and to help the church live out its commitment to anti-racism and intercultural community. This event will be offered again in May 2023 to an expanded cohort of leaders, lay people, and ministers who are new to the United Church.

Plans for 2023

In addition to our regular programming and courses, Dio will begin to develop a long-term plan for its future as a renewed ecumenical institution. In the face of challenges and transitions within and beyond church walls, the college will seek to discern its role and the ways it will continue to form leaders for a vibrant future church.

Back in Person: Buzzing with Joy and in Gratitude

Emmanuel College was back in person after two long and challenging pandemic years online. We had a heart-warming in person orientation with close to 100 new and "returning" students who had never been to the college. We held a special fall graduation celebration for those who convocated online in 2020 and 2021.

Spiritual and religious practices on Wednesday are alive and well and were offered Monday through Thursday with the leadership of Spiritual and Community Life Coordinator, Beth Ann Fisher, through the leadership of our first ever Interfaith student Spiritual Life team who is taking a year-long course "worship and ritual leadership practicum" with instructor, the. Rev. Dr. David Kim-Cragg.

Hybrid Master of Divinity Program

Building on our experience of remote delivery throughout the pandemic, our Master of Divinity program has been approved by the University of Toronto to be offered in a hybrid mode of delivery. This means that up to two thirds of the degree can be done online. We are excited as we hope this will reach more prospective students outside of the Greater Toronto Area.

All Members of EM Re-Connected and Networking

One of my priorities as principal is to re-connect all members of the College as we emerge from many years apart. We are anticipating many wonderful anniversary celebrations and reunions with the UCC's 100th anniversary in 2025 and EM's 100th anniversary in 2028, so keep an eye out for our various events to celebrate these historical milestones.

Gardening Project

Another goal I am focusing on as principal is the land on which we are located. Concurring with Victoria University's strategic framework on sustainability, and commitment to right relations with Indigenous communities which is laid out in the EM strategic plan, I am seeking to create a garden with the participation of the Indigenous community and to remove the lawn grass from our courtyards. This idea has generating some excitement and we received a starting grant from the United Church Foundation's Seeds of Hope to get us started! So please stay tuned and feel free to share your ideas and spread the news. it is my hope that the courtyard where the crucified woman statue is standing will be dug up next spring!

Financial Support

Emmanuel College continues to provide significant financial support to students. Through the John W. Billes Fund, Emmanuel continues to provide 100% of tuition coverage to all domestic students who are registered full-time in the M.Div. program and who are engaged in The United Church of Canada's candidacy pathway process. All incoming domestic full-time students are eligible for our **Entering Theological Education grant, which offers 50% tuition coverage to their first year courses**. Rev. Grant Dillenbeck

Grant was raised on a farm near Napanee, Ontario and attended Grace United Church in Napanee where he was greatly influenced by his involvement in the youth ministry there. With the encouragement and support of his home church minister, Rev. Guy Case, he sensed a call into ministry and was recommended as a candidate by his home congregation and Belleville Presbytery. Grant attended Queen's University in Kingston where he obtained a B.A. in Sociology and a Masters of Divinity. At convocation from Queen's Theological College, Grant received the Heeney, Waddell, Leitch academic award which his father-in-law, the late Rev. Dr. George Richardson, had received 25 years before. During his time at Queen's Grant gained an awareness of global justice issues and was involved in peace and human rights

organizations, including being the chair of the Kingston Amnesty International group. A week after ordination Grant married Ruth Richardson and they travelled to Alberta where Grant had been settled to serve the United Churches in Turner Valley and Black Diamond, southwest of Calgary. Grant chaired the Division of Church in Society for Alberta and Northwest Conference, was on the Executive of Conference, and attended the meeting of General Council in 1986. In 1990 Grant and Ruth moved to Ottawa, bringing them closer to family. Grant served 11 years in team ministry at Bells Corners and as Intentional Interim Minister at Riverside and MacLeod-Stewarton (now Centretown), United Churches, before being called to Stittsville United in 2005 where he served for 17 years before his retirement. 


Rev. Dr. Walter Oskar Wilhelm von Boetticher

1936-2022



1925 – 2023








Rev. James ("Pat") Whyte

after which he retired to Ottawa. He was a kind and gentle man who loved to listen to the life stories his parishioners and friends wanted to tell.




Rev. Lester Burry Wiseman



Preamble This document outlines the Eastern Ontario Outaouais Regional Council's policy and best practices regarding the disposition of proceeds from the sale of congregational property.

Policy:

When Congregational property is being sold by a *Community of Faith that is not disbanding, these are the guidelines for the use of net proceeds from the sale:

Not Disbanding:

- a) 10% be remitted to the United Church of Canada for the on-going support of Indigenous Ministry.
- b) 90% be retained by the Community of Faith with an approved ministry plan for the use of the proceeds by the Regional Council that is financially sustainable. The Regional Council will normally require that the remaining capital from the sale be protected and invested and that the Community of Faith be limited to drawing up to 5% of the value of the invested capital in any given year to support its operating budget. If the Community of Faith puts before the Regional Council a ministry

plan, the Regional Council may allow the Community of Faith to use some or all of the remaining capital from the sale to implement the ministry plan. This may include capital expenses.

Disbanding:

When a Community of Faith is disbanding, the disposition of all net assets (cash, and property) will be disbursed as follows with an understanding that the first 80% of assets be invested to yield on-going income for the long-term ministry of the United Church of Canada such as General Council, Regional Councils, Communities of Faith and/or United Church Outreach Ministries.

- a) 10% be remitted to the United Church of Canada for the on-going support of Indigenous Ministry.
- b) 10% be remitted to the United Church of Canada Mission and Service Legacy Fund for the on-going support of the ministry of the United Church
- c) 10% be remitted to the Eastern Ontario Outaouais Regional Council Transformation and Vision Fund.
- d) 50% be remitted to the Eastern Ontario Outaouais Regional Council Mission and Ministry Legacy Fund which supports the Mission and Ministry of the Regional Council such as youth ministry, social justice endeavors, and mission support ministries like church camps, outreach ministries, chaplaincies etc. (see terms of Reference for Mission and Ministry Legacy Fund). On occasion, the Regional Council will entertain some or all of this amount being directed to geographically neighboring Communities of Faith for long-term investing or invested long-term with the Region for a specified purpose or ministry (see note below). This designation requires a specified plan that is reviewed and recommended by the Finance Committee and approved by the Executive.
- e) 20% be remitted to mission activities that the Community of Faith has a historical financial commitment and/or congregational voluntary value, and a maximum of half this amount is eligible for organizations not associated with the United Church of Canada. The amounts from this 20% do not have to be invested long-term.

The Rules of Debate and Order

1. Presiding Officer

The function of the Presiding Officer is to preside, with all that that implies. The Presiding Officer should not attempt to control the decision of the Court, but may express opinions on any matter before the Court. If the Presiding Officer wishes to introduce a motion or to present a report, the Presiding Officer shall ask another member to preside, and while out of the Chair shall be an ordinary member of the Court and must not assume the chair until the matter is disposed of. The Presiding Officer does not vote except in the event of a tie.

2. Questions of Privilege and Order

(a) A point of order may be raised while a matter is pending or while another member has the floor. When a point of order is raised it must be dealt with by the Presiding Officer without debate. If a member has the floor when a point of order is raised by another member, that member must yield the floor until the Presiding Officer has made a ruling.

(b) Any member of the Court may appeal from a ruling of the Chair, but only at the time when the ruling is made. But where a ruling is a precedent the general question of its correctness may be brought up later when there is no business pending, but cannot then affect the business transacted under the ruling.

(c) When an appeal from a ruling is made, the Presiding Officer should state the point at issue, and may give reasons for the ruling. The Secretary shall then put the question in the following form: "Is the ruling of the Moderator (or such other title by which the Presiding Officer is known) sustained?" If the vote is a tie, the Presiding Officer is sustained. The Secretary shall declare the result.

3. Orders of the Day

(a) When an agenda has been adopted that does not specify the time for its items, such items are considered without time limit, unless the Court decides otherwise by a two-thirds (2/3) majority of those voting.

(b) When an agenda has been adopted that specifies the time for particular items, such time shall be strictly adhered to, unless the Court decides otherwise by a two-thirds (2/3) majority of those voting. (2010)

4. Order of Priority on Motions

- (a) To close. (2010)
- (b) To fix the time to adjourn.
- (c) To adjourn.
- (d) To take an immediate vote (two-thirds (2/3) vote required).
- (e) To limit or extend limits of debate (two-thirds (2/3) vote required).
- (f) To postpone definitely.
- (g) To commit or refer.
- (h) To amend.
- (i) To postpone indefinitely.
- (j) To deal with main motions.

5. Procedures on Motion

(a) A member of the Court proposes a motion.

(b) It is seconded. If there is no seconder, the motion fails.

(c) When the motion is duly moved and seconded, the Presiding Officer states the motion and declares it open for discussion. If the mover has not already done so, the mover has the right to introduce the discussion.

(d) A motion is out of order when it conflicts with a resolution previously passed at the same session unless it is a motion to reconsider.

(e) Without the permission of the Court, no member may speak more than once on any motion or on any amendment thereto.

(f) The mover of a motion has the right of reply before any vote is taken thereon or on any amendment thereto. Even when the Court has directed that an immediate vote be taken on a motion, the mover still has the right of reply.

(g) When a motion has two (2) or more clearly defined parts or points of issue, and any two (2) members request that it be divided, a separate vote must be taken on each part.

(h) Any motion may be withdrawn but only with the consent of its mover and seconder.

(i) After a motion is under consideration a question of order cannot be raised against it unless the motion is ultra vires.

6. Procedure on Amendments

(a) Any member except the mover or the seconder of the motion may move a relevant amendment thereto.

(b) An amendment must be seconded, and if there is no seconder it fails.

(c) A motion is amended by striking out certain words or clauses, adding certain words or clauses, or striking out all after the word "Resolved" (or the word "that"), and inserting another motion that will dispose of the matter. An amendment that merely negatives a motion before the Court is out of order.

(d) There may be an amendment to the amendment, provided it has been duly seconded.

(e) There is no limit to the number of amendments, but at any one time there can be before the Court only the motion, the amendment, and the amendment to the amendment.

(f) When an amendment is disposed of, other relevant amendments may be proposed.

(g) The discussion is always on the immediately pending question, and it must be voted on first. When a motion, an amendment, and an amendment to the amendment are before the Court, the two first named are "pending questions" and the last is the "immediately pending question." When the immediately pending question is disposed of, the one above it then becomes the immediately pending question, until the whole matter is disposed of.

(h) When an amendment carries, it is not thereby adopted as the finding of the Court, but only changes the proposition under discussion.

(i) When a motion, an amendment, and an amendment to the amendment are before a Court, three (3) separate votes including "for" and "against" must be taken. The first determines whether the amendment shall be amended, the second determines whether the motion shall be amended, and the third determines whether the motion, in whatever form it is then before the Court, shall be adopted or rejected.

7. Procedure on Voting

(a) A vote is generally taken viva voce or by a show of hands. The Presiding Officer may ask for a standing vote. Upon motion duly passed, the vote shall be taken by ballot. In all actions of Church Courts regarding membership in the Order of Ministry requiring voting procedure, the vote shall be taken by ballot unless waived by unanimous consent; that is, on motion to waive, no dissenting vote is cast. See also sections C.5.7 and D.4.4 of the bylaws.

(b) In the event of a tie, the Presiding Officer shall cast the deciding vote.

(c) An affirmative vote on a motion does not validate any motion that is ultra vires of the Court, or that contravenes a decision of a higher Court.

(d) In the conduct of United Church business, voting by proxy or by mail-in ballot is not permitted. Voting by telephone or by email is permitted only when it occurs during a meeting that is held in a manner that allows all of the persons participating to communicate with one another simultaneously and instantaneously. (2010)

8. Procedure on Motion to Reconsider

(a) A motion to reconsider may be made at any time when the floor is vacant; but the actual reconsideration has only the same priority as the motion to be reconsidered.

(b) A motion to reconsider must be moved by a member who voted with the majority. Any member may second.

(c) If a motion to reconsider is dealt with at the same meeting in which the original motion was adopted, it will fail unless two-thirds (2/3) of those voting are in favour thereof. If a motion to reconsider is dealt with at a subsequent meeting of the Court, a majority of those voting determines the question.

(d) When any motion to reconsider has been duly seconded, all action on the original motion is suspended until the motion to reconsider has been disposed of. No motion to reconsider can be entertained by the Court where action has already been taken under the original motion.

(e) A motion cannot be reconsidered twice unless materially changed on the first reconsideration. If a motion to reconsider has been lost, it cannot be repeated.

(f) A motion to reconsider is debatable only when the motion to be reconsidered is debatable. It cannot be amended, postponed indefinitely, or committed.

9. Motion to Refer

A motion to refer is debatable, but only as to the wisdom and manner of the proposed referral. It requires only a majority of those voting.

10. Motion to Postpone Indefinitely

A motion to postpone indefinitely, when in order, must be put without debate. If the motion is lost, it cannot be repeated or reconsidered. If CARRIED, the motion along with all amendments is removed from debate. At any time, it may be brought back before the Court by motion duly seconded and CARRIED. In such case the question is before the Court in exactly the position it held at the time it was removed from debate. A motion to postpone indefinitely can have no conditions attached to it. If a time is specified, it immediately ceases to be a motion to postpone indefinitely and becomes a motion to postpone definitely and is debatable. (2007)

11. Motion to Take an Immediate Vote

If a motion to take an immediate vote (for which a two-thirds (2/3) vote is required) is CARRIED, the vote shall be taken immediately. The mover of the main motion, however, shall have the right to reply before the vote is taken. If such a motion fails, debate on the main motion shall continue. A motion to take an immediate vote is not debatable.

12. Motion to Adjourn

A motion to adjourn is intended to suspend a meeting until another time. A motion to adjourn is in order only if there is already an agreed-upon time and place for resuming the meeting, or if the motion specifies a time and place for resuming the meeting. A motion to adjourn requires a seconder. Only the conditions attached to the motion to adjourn, such as time and place for resuming the meeting, are debatable; the wisdom of adjourning is not debatable. (2010)

13. Closing a Meeting (2010)

(a) A motion to close is intended to terminate a meeting. A new meeting may commence, at a future time, by previous agreement or by call. There can be no conditions attached to a motion to close. A motion to close requires a seconder. A motion to close is not debatable. (2010)

(b) When all the business and purposes of a meeting have been attended to and the Presiding Officer is satisfied that there is no further business before the Court, the Presiding Officer may declare that the meeting is closed, without the need for a motion to close. (2010)

14. Committee of the Whole

(a) Any Court, for greater freedom of discussion, may, on motion duly made, seconded, and CARRIED, move into a Committee of the Whole. Any such motion is neither debatable nor amendable, except only as to the scope of the subject to be discussed. The motion is not in order if there is a pending motion to adjourn the meeting or to postpone discussion on the subject. (2007)

(b) The first act of the Committee of the Whole is to appoint a chairperson and a secretary. A separate minute of the proceedings is taken. (2007)

(c) The ordinary limitations of debate do not prevail in the Committee of the Whole. The chairperson restates the matter(s) to be considered. Discussion is then opened and is conducted informally. Motions need not be seconded. Unless the resolution creating the Committee of the Whole imposes restrictions, there are no restrictions, within reason, on the number of times a member may speak or on the length of speeches, except that priority is given to a member who has not yet spoken. (2007)

(d) When the deliberations of the Committee of the Whole are concluded, the Committee will dispose of a motion that the Committee rise and report; this motion does not require seconding and is neither debatable nor amendable. When this motion is passed, a report is prepared and submitted to the chairperson of the main meeting, who reconvenes the main meeting. (2007)

(e) A Committee of the Whole can neither adjourn nor terminate; it only can report back to the main meeting. It can, of course, recess briefly to prepare its report. (2007)

15. General

(a) When a member utters language that another member considers offensive, the latter may require that the words be taken down. The speaker is then allowed to proceed. When the speaker yields the floor, the words complained of may be considered and dealt with. Such words may not be privileged.

(b) Members of any Court should at all times therein conduct themselves with dignity, fairness, and understanding. The prime concern should be the good order and welfare of the church.

(c) In any point not covered in The Manual, the parliamentary rules accepted in Canada (Bourinot) shall be followed.

Enabling Motions

1. <u>Regional Council Roll:</u>

That the Ministerial Roll of the Regional Council (including candidates for Ordination, for Commissioning and Admission currently serving in appointment and who are recognized as the sole ministry personnel within the pastoral relationship) and the non-Ministerial Roll of the Regional Council thus constituted be now taken as read.

2. <u>Other Delegates</u>:

That anyone who has a role to play at the General Meeting of the Eastern Ontario Outaouais Regional Council (e.g. members of the Regional Council Executive, Chairs of Leadership Teams and who has not been appointed as a delegate by her/his Community of Faith, be a full delegate with all the privileges of other delegates, and that the youth and young adult representatives from each Community of Faith be full delegates.

3. <u>Corresponding Members</u>:

That the students serving this Regional Council; those present as invited guests of this Regional Council, resource persons, all who have registered for the Youth and Young Adult Event and other guests recognized by this court, be invited to sit as corresponding members of the Court.

4. <u>Minimum Number of Members at Meetings</u>:

That the minimum number of members for any session of this Regional Council is present (C.4.3, The Manual 2021).

5. <u>Agenda</u>:

That the agenda as printed and circulated, the reports, and the daily Agenda, be adopted as the Agenda for this meeting, subject to such changes as may be determined by the Business Leadership Team and approved by this Court.

6. <u>Procedures for Reports</u>:

That the following procedure with respect to reports being presented at the Regional Council be adopted.

- a. Reports and any attendant recommendations be dealt with in the allotted time.
- b. If action has not been completed in the allotted time, then the Regional Council may:
 - i. Request that additional time on the Agenda be arranged by the Business Leadership Team
 - ii. Refer the report with its recommendation(s) to the appropriate body or bodies concerned, along with power to issue
 - iii. Refer the report with its recommendation(s) to the Executive of Elders of the Regional Council for such action as the Executive deems appropriate.

7. <u>Meeting of the Executive</u>:

That the Executive (which is empowered to act on behalf of the Regional Council between the meetings of the Court) be empowered to meet, if necessary, during the sessions of this Regional Council meeting and report those matters which require the approval of this Court.

8. <u>Inclusive Language</u>:

It is recommended that every attempt be made to use inclusive (non-sexist) language in all worship, reports, petitions and discussions in this Court.

- 9. <u>Business Leadership Team</u>: That the *Business Leadership Team* be members from the Planning Leadership Team.
- 10. <u>Scrutineers</u>: That the *Scrutineers* be appointed from the membership of the Court.

Preamble

This document outlines the Eastern Ontario Outaouais Regional Council's policy and best practices regarding requests for funding outside of the approved annual budget at the annual meeting.

Policy

It is the policy of the Eastern Ontario Outaouais Regional Council to affirm and uphold the use and function of the Business Committee for matters coming to the floor of the Annual Meeting of the Regional Council.

It is the policy of the Eastern Ontario Outaouais Regional Council that any motion committing the Eastern Ontario Outaouais Regional Council to the expenditure of non-budgeted sums of money be required to have a budget attached;

It is the policy of the Eastern Ontario Outaouais Regional Council that any motion committing the Eastern Ontario Outaouais Regional Council to non-budgeted expenditures which are presented during the Annual Meeting be automatically referred to the Executive who may request input from the Finance Team first before making the decision;

It is the policy of the Eastern Ontario Outaouais Regional Council that in the interests of fairness and justice, requests for funding of projects or groups not covered in the existing Financial budgets be subject to conditions and criteria similar to those that are currently expected of requests for Mission Support, and other funds available within the Regional Council.
