- 1. Finance Rev. Brian Cornelius
  - See 2024 financial report as **Appendix A**<sup>1</sup>
  - See *Treasurer's Report (March 14, 2024)* as **Appendix A<sup>2</sup>** Brian provided the following summary:
    - 1. Banking:
    - a) Electronic Funds Transfer is working and happening, and we have been pretty successful with it. There is a very solid record keeping for audit purposes.
    - b) We can do e-transfers, and I did one as a test with Paul Dillman one of our cheque signers, so I will be developing the checks system for that, but all the updates have occurred....so we are in good shape. This is more expensive so using EFT is better.
    - 2. Quickbooks online: While it has been a learning curve for me, we have now migrated the books to quickbooks online. It was trickier than I thought, however, I have managed to get it all set up and get everything balanced as well as learn new ways of tracking our information that is accessible and more readily transparent. I am working on making the reports on quick books identical with our Reviewed Financial statements. While I have reports on Quick books, I am still learning how to make pdf reports for you,
    - 3. I am attaching an updated Financial Report with the final numbers for 2023 and expenditures for 2024 in the Governance and Mission and Ministry files. Since I had to rework the books and we adopted a budget, I took the liberty of proposing a simplified way of reporting (with less categories) and a means to better "see" how the life of the Region is funded. I would like feedback on the format that I am forwarding to you. Do you like the categories and how it is set up.

4. If we concur with this new format, I will then finalize the Reviewed Financial Statement using the new format and set up the Review in April so that we have documentation ready for the May meeting of the Regional Council. Please note, that the report does have the approved budget by the Executive to be confirmed at the Regional Meeting. One of the reasons for large surplus at this point, is that the transfer of monies for operations happens January 1 and then we slowly spend the money through the year.

Mostly this is for information, and I do not need discussion at the meeting, other than to welcome any feedback on the new formate as outlined in item 3. Joel, a simple motion to received the attached financial report would be suffice.

#### 1. Banking:

- a) Electronic Funds Transfer is working and happening and we have been pretty successful with it. There is a very solid record keeping for audit purposes.
- b) We can do e-transfers, and I did one as a test with Paul Dillman one of our cheque signers, so I will be developing the checks system for that, but all the updates have occurred....so we are in good shape. This is more expensive so using EFT is better.
- 2. Quickbooks online: While it has been a learning curve for me, we have now migrated the books to quickbooks online. It was trickier than I thought, however, I have managed to get it all set up and get everything balanced as well as learn new ways of tracking our information that is accessible and more readily transparent. I am working on making the reports on quick books identical with our Reviewed Financial statements. While I have reports on Quick books, I am still learning how to make pdf reports for you,
- 3.. I am attaching an updated Financial Report with the final numbers for 2023 and expenditures for 2024 in the Governance and Mission and Ministry files. Since I had to rework the books and we adopted a budget, I took the liberty of proposing a simplified way of reporting (with less categories) and a means to better "see" how the life of the Region is funded. I would like feedback on the format that I am forwarding to you. Do you like the categories and how it is set up.
- 4. If we concur with this new format, I will then finalize the Reviewed Financial Statement using the new format and set up the Review in April so that we have documentation ready for the May meeting of the Regional Council. Please note, that the report does have the approved budget by the Executive to be confirmed at the Regional Meeting. One of the reasons for large surplus at this point, is that the transfer of monies for operations happens January 1 and then we slowly spend the money thr

# **Location for Annual General Meeting – May 30-31, 2025**

As the date for the 2025 annual general meeting has been decided, it is now time to select a location. EOORC events are a major undertaking, especially the holding of a multi-day annual meeting. Planning for an event of this size and complexity takes considerable time; many venues are booked months and even a year before the event; and often audio-visual equipment is also rented months or a year in advance. Thus, it is prudent to select the geographic area now as well as any specifications about the location.

For 2024 the specifications included: approximately 150 participants in plenary; four additional rooms for youth, child care, business office, chaplain plus space for food service and registration; availability of space for three days (one day for set-up plus two meeting days); good technology; accessibility; parking; preferably in a church or near a church where a Celebration of Ministry service could be held. A detailed outline of specifications is available (it includes, for example, the requirement for fair-trade coffee and tea as well as vegan and gluten-free meals).

In addition, the choice of a venue is influenced by the objectives that EOORC would like to achieve at an annual general meeting.

Decision: Where would the Executive like to hold the 2025 AGM? Does the Executive have objectives and specifications for the venue?

## D. GENERAL COUNCIL

# **D.1** Membership

#### **D.1.1** Members of the General Council

The General Council consists of the following 260 members. They must all be ministry personnel or lay members of the United Church:

- a) the Moderator;
- b) the immediate past Moderator;
- c) the General Secretary of the General Council;
- d) the leading Elder or presiding officer of each regional council;
- e) 204 members elected by the regional councils on the following basis:
  - i) Number: each regional council elects five members *plus* an additional number allocated to it based on the proportion of communities of faith within the bounds of that regional council to the total number of communities of faith in the United Church;
  - ii) Lay/ministry personnel balance: a minimum of 1/3 of the members elected must be ministry personnel on the roll of the regional council, and a minimum of 1/3 of the members elected must be lay members of communities of faith within the bounds of the regional council other than ministry personnel;
  - iii) Diversity: attention is given to diversity of gender and age, racial and cultural identities, and sexual expressions, as provided in policies set by the General Council; and
  - iv) Timing: the election takes place, where possible, at least one year before the next regular in-person meeting of the General Council;
- f) 15 members chosen by the National Indigenous Organization who are in addition to any Indigenous members elected under paragraph D.1.1 e) above;
- g) the members of the Executive of the General Council who will be continuing to serve on the executive following the first General Council meeting of the triennium; and
- h) a number of members to be elected by the Executive of the General Council, on the recommendation of the regional councils, for the purpose of ensuring diversity in the General Council after the members listed in paragraph D.1.1 e) above have been determined to bring the total number of members to 260.
