This is based on the draft Minutes for Annual General Meeting of November 25, 2024, the 2024 board member approval submission, contact list provided and receipt of other required documentation per the Incorporated Ministries Policy of The United Church of Canada.

d) Concur with the recommendation of the Future Through Property Leadership Team to authorize the trustees of the Low United Church to sign an agreement of purchase of Low United Church, 85 Martindale Road, Low, Quebec, J0X 2C0 by BWN Inc. for a sale price of \$187,000. The time frame for closing is 30 days with an ideal occupancy after October 19, 2025. The property is sold as is-where is. The exclusions from the sale include all religious artifacts.

#### **CARRIED**

#### **Business Arising –**

- a) Way Forward Towards 2035 Rev. Mary Royal-Duczek recapped some on two events that took place recently which were themed on visioning the Church forward: over 110 people at each event. These events were attended by church leadership and evaluations have been very positive. Those in attendance appreciated the space created for dialoguing about the future of the Church. A congregational resource (Towards 2035 information packet) was circulated ahead of these meetings and Mary is making it available for any congregation wanting a copy.
- b) Ottawa Archives Rev. Eric Hebert-Daly shared that archives which were intended to go to Toronto have been delayed and therefore remain at the Ottawa Archives. A future decision about archives may come back to the Executive, as original plans to store archives in Toronto may not happen as intended.
- c) Stittsville United Church Commission Rev. Cindy Casey shared that the Commission is meeting with a person tomorrow to potentially fill the current vacancy at Stittsville. Rev. Shaun Yaskiw has been providing ongoing pulpit supply, and the Commission is extremely grateful for his help to the Stittsville congregation in this role.
- d) Centretown United Church Centre 507 Rev. Eric Hebert-Daly shared that he has communicated with folks at Centretown United Church and was informed that many of the concerns about fire-safety are being looked at in response to recommendations from the Fire Marshall's report. Details will be forthcoming. It was suggested that Centretown United Church consider funding options (endowments, grants) to help pay for a fire alarm system. Eric will provide a written report next week following results from meeting with folks at Centretown United Church.

## **Regular Business**

1. **Finance** – Rev. Brian Cornelius, Regional Council Treasurer sent his regrets; informed that recommendations will be coming to the November 2025 Executive meeting.

- 2. **Pastoral Relations Commission (PRC)** Rev. Whit Strong shared that concerns have been raised about LLWL and requests to administer the sacraments. More news to come.

- 3. **Future Through Property Leadership Team** Rev. Mary Royal Duczek shared that the leadership team continues to work towards creating a culture shift in the way communities of faith deal with property, in particular, to involve the leadership team sooner than when coming to final decision to sell property. The General Council office has asked the Future Through Property Leadership Team to prepare a property inventory.

It was shared that there has been considerable growth of *God's Beloved*, and the West End Cluster is looking to help address needs and share resources to support this community.

The planning team continues to meet; local arrangements is also being involved in the planning.

5. **Vision Keepers** – Rev. Mary Royal Duczek shared that the Vision Keepers will be focused on impacts of Towards 2035 report and will be considering new ways the Executive can function to better help support congregations. Currently, there are six executive members serving as Vision Keepers. At there upcoming meeting on October 22<sup>nd</sup> the Vision Keepers will be looking at information provided through the General Council office for local congregations. The first steps for the Vision Keepers will be to begin familiarizing themselves with different place in the region.

#### **New Business**

a) Copyright Issues (Order of the Day 10:30 am) – Rev. Alydia Smith, Identity and Mission Network Coordinator, highlighted the false understanding that owning a copy of a hymnbook enables free reproduction. This is false, copyright license must always be purchased for any reproduction of music, including projection. Musicians must be credited and paid for their work – many of which are members within The Untied Church of Canada. One License copyright license can be purchased for all music within the *Then Let Us Sing!* hymnbook. All songs being used must be reported (when used) in addition to purchasing a copyright license. Then Let Us Sing! (<a href="https://thenletussing.ca/">https://thenletussing.ca/</a>) Gathering Worship: Resources for Worship Planning (<a href="https://gatheringworship.ca/">https://gatheringworship.ca/</a>) were referred to as additional resources. It was also highlighted that any reproduction of music should be exact replicas and not amendments (i.e. replacements to include inclusive language). <a href="https://prezi.com/v/view/C3g5vc6xsFkRwgNFXNrj/">https://prezi.com/v/view/C3g5vc6xsFkRwgNFXNrj/</a>, etc.) Alydia shared that there is a Then Let Us Sing! Event happening at Orleans United Church, October 24<sup>th</sup> at 7:30 PM.

Members of the Executive discerned what may be helpful (what comes next) in response to the information that was shared. It was suggested to upload information to YouTube. It was suggested that communication be sent out to all Communities of Faith (CofF) about the necessities of respecting copyright laws. Julee Pauling will share detailed notes that were taken for Alydia's Presentation into SharePoint. It was suggested that Paul Sales can be contacted for information about the Then Let Us Sing! digital hymn resource. What can be done to help CoFs who struggle to pay for copyright license.

It was suggested that the regional council offer a one-year license subscription to all communities of faith within the regional council (suggested as a centennial anniversary gift) — which could produce up to a 30% discount. Vision & Transformation Fund may be a possible resource to find finding, but this may offset giving to other ministries. It was suggested that SOCAN be approached. It was suggested to seek solution directly form One License. A more formal proposal will come to a future meeting.

b) "Oh Yeah!" Quick Reminders to Communities of Faith – Rev. Eric Hebert-Daly shared that there will be a monthly reminder circulated with updates for communities of faith (i.e., rules around email polls, how to handle cash received from offering, charitable status, rules around copyright, etc.). It was emphasized that the means of communication should be a focus for this type of information. It was reminded that folks need to give their permission to receive materials. It was suggested that a request to share information this kind of information go to church Official Boards.

**Report from the Equity Support Person** – Rev. Frank Emanuel shared that it would be helpful for folks to include their pronouns when naming themselves on Zoom. Frank will share the results for the checklist in SharePoint.
